ORDER

1. This order shall dispose of the appeal filed by Shri Sanjay Chandekar in respect of ID No.75.
2. The appellant in his Original RTI application dated 01.07.2022 had sought following information / documents:
 - i. Pl. provide the details of the honorarium paid to Nari Samata Manch, NGO, Pune in the years 2018-19, 2019-20, 2020-21 & 2021-22.
 - ii. Pl. provide the MOU or Contract copy with Nari Samata Manch, NGO for providing their various services to FTII.
 - iii. Pl. provide the Notice/ Letter/ Communication sent by the PIO to Ms. Suchitra Sathe (Ex. I/c of Internal Committee regarding giving the 3rd party information to applicant and her response to the PIO w.r.t. RTI application dated 07.03.2022 regarding information asked as pt.no.6,7 & 10 along with entries in the outward & inward registers of both the sections.
 - iv. Pl. provide the prescribed essential qualifications and preferable qualifications for the following posts – Maintenance Engineer, Maintenance Manager, Research Assistant (Technical)
 - v. List of total number of posts in FTII which are vacant and from when?
 - vi. Pl. provide the existing qualifications of the present Research Asst. (Technical) and at the time of appointment.
 - vii. Pl. provide the guidelines/rules regarding the first & second ACP.
 - viii. In absence of the previous Director Sh. Kainthola, details of how many times the charge of Director was given to whom & from which to which date.
 - ix. Pl. provide all the leave record details of Ms. Suchitra Sathe (Asst. Prof. Video Editing – on contract) from 2015 till the date sanctioned by Dean (TV).
 - x. Pl. furnish the official communications, orders, circulars etc. regarding the 1 year contract faculty of Video Editing who will also work or look after as a HoD of the TV Editing Department.

- xi. Pl. provide the details of all the panellists for the Interviews including outside experts held for the contract faculty post of Asst. Prof., Video Editing, along with the Dates of Interview held from 2015 till 2022.
 - xii. Pl. provide the list of various Government & Non-Government Committees in FTII with the names of posts in it for the years 2016 till 2022.
 - xiii. Is there any board or boards displayed at the various places in the campus regarding RTI & the names of various PIOs/ CPIO? Pl. provide the details. If any, on what date the sign boards were displayed?
3. The CPIO, Shri S.K. Dekate, Administrative Officer has sent a reply on 26.07.2022 and Smt. Minal Kakde, Chief Accounts Officer as PIO has furnished reply on 18.07.2022 and thus all the queries are replied by CPIO and PIO.
 4. The Appellant has made the present appeal disputing on the reply given by the PIO that the information provided by the PIO is incomplete, misleading or false.
 5. As the Appellant has not specified as to how the provided information is incomplete, misleading or false, the First Appellate Authority upholds the decisions of the CPIO and PIO.

The appeal is therefore disposed of.
