- 1. This order shall dispose of the appeal filed by Shri Sanjay Chandekar in respect of ID No.83.
- 2. The appellant in his Original RTI application dated 12.08.2022 had sought following information:

Pl. give the communication details (letter, replies, e-mails, notings, orders etc.) between the FRO (Ms.Debjani Haldar & FTII Authorities (i.e. Prof. Screen Studies on contract, Dean, Registrar, Director) RGARDING shifting her office from old faculty block to the office hall of the Film Library in Film Editing Building during 2019- March 2021.
 - 2. Pl. give the communication details (letter, replies, e-mail, notings, orders etc.) from the FRO (Ms. Debjani Haldar & FTII Authorities (i.e. Prof. Screen Studies on contract, Dean, Registrar, Director, etc.) TO Mr. Sanjay Chandekar (I/c Film Digitization Project) & Sh. Sunil Jajjal (UDC) RGARDING Vacating their sitting place in the office hall of the Film Library in Film Editing Building immediately for Ms. Debjani Haldar (FRO) in March 2021.
 - 3. Pl. give the Date of Submission of a File to the Registrar Sh. Varun Bhardwaj or Registrar Office regarding Up-Gradation of Radio FTII (during 2017-18). Pl. also give a Photostat copy of the Entry Register (Inward/Outward Register) in the Registrar Office.



- 4. Pl. give a copy of the complete File submitted to the Registrar Sh. Varun Bhardwaj regarding Up-Gradation of Radio FTII with his remarks & to whom it was further submitted.
- 5. Pl. provide O.M./Orders/letters/G.R./Circulars etc. from Central Govt./ DoPT/ CIC/ regarding "Not to provide the Third Part Information" AND High Court & Supreme Court Orders regarding the same. त्रयस्थ पक्षाची माहिती देवू नये असे शासनाचे आदेश पत्रक, राज्य आणि केंद्रीय माहिती आयोगाचा निर्णय, तसेच उच्च न्यायालय यांची त्रयस्थ पक्ष संदर्भात असणारी ऑर्डर प्रत

- 8. The job profile of Ms. Sonal Inamdar, CTA/ Radio Programme Asst. while working at Dean (TV) Office.
- 9. Details of nature of jobs/ work/ tasks were given to Ms. Sonal Inamdar by the IC chairperson or by any IC Member while working for the Internal Committee during the period when she was working with Dean (TV) office from 22.06.2022 till October 2019.
- 10. Pl. give the copy of the complaint about Prof. A.B. Sonone regarding the harassment, filed by Neeta Tupare on him, in which my name (Sanjay Chandekar) also appeared number of times, received by the Internal Committee and a Photostat copy of the Registrar of IC in which entry of it was made.
- 11. Pl. give the date & month on which IC submitted the report about Prof. Ashin Sonone to Director regarding a harassment case filed by Neeta Tupare on him and in which my name is also appearing for number of times.
- 12. Pl. give the complete report about Prof. Ashwin Sonone which IC submitted to the Director regarding a harassment case filed by Ms. Neeta Tupare on him as in the complaint filed by Ms. Neeta Tupare, my name (Sanjay Chandekar) was appeared number of times.
- 3. The Appellant has made the present appeal disputing on the response from the PIO that the information not received within the time limit.
- 4. It is seen that the Appellant had made the original RTI application on 12.08.20022 and the present appeal made on 11.09.2022.
- 5. The contention of the appellant is correct and therefore accepted. The CPIO/Administrative Officer is directed to provide information within 10 days.



The appeal is therefore disposed of.
