  - (d) Prior Approvals of the latest all orders of constitution of the Internal Committee after 12.10.2021 till the date of reply.
  - (e) Consent of all the members for accepting the position as a Member in the I.C. in the orders after 12.10.2021.
  - (f) Third Part Notice sent to the Research Assistant (Technical) regarding making available her service book for the inspection to the applicant.
  - (g) Photostat copy of the Service Book of the Research Assistant (Technical) who retired on 31st July 2022.

3. The Appellant has made the present appeal disputing on the reply given by the CPIO that the details not provided and thus CPIO refused access to information requested.
  4. The First Appellate Authority upholds the decisions of the PIO.
