This order shall dispose off the appeal filed by Shri Sandeep Chatterjee FATIP/A/E/21/00003 in respect of ID No.51.

The appellant in his RTI application dated 12.12.2020 requested for the following information :

In the context of the Memorandum of Charge Sheet against Shri Sandeep Chatterjee, Professor & Head, Dept. of Direction & SPW (Reference No.A-19011/3/2008-Est.). Please furnish valid copies of notings, approvals, findings, and/or orders given by then-incumbent Chairman, FTII for the following Exhibits – 1. Exhibit B(1) & C(1) & D(1) – D(2) – copy of Show cause notice dated 22.07.2019 and copy of reply dated 01.08.2019 from Shri Sandeep Chatterjee and copy of Representation dated 07.01.2019 from Shri Sandeep Chatterjee. 2. E(1)-E(2) & F(1) – F(2) – copy of Show cause notice dated 19.07.2019 and copy of reply dated 01.08.2019 from Shri Sandeep Chatterjee. 3. is denied or partially provided, please mention the relevant clause(s) of the RTI Act for the same.

The PIO, vide his reply dated 11th January, 2021 provided the information.

The appellant contends that the necessary information is denied in an arbitrary manner.

Since the above information is indeed part of ongoing disciplinary process of the employee and can't be disclosed to the appellant, the PIO's invocation of Section 8(1)(h) of RTI Act stands. The appeal is therefore disposed of.

If he is not satisfied with the information provided, he may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066** within the stipulated time.
