 - 2. All the Approvals / Sanctions by the Director regarding giving payments to the concerned during 2013-14, 2014-15, 2015-16, 2016-17, 2017-18.
 - 3. Kindly provide all copies of the proposals from concerned to give such payment to the said organisation.
 - 4. All receipts / acknowledgments of payments received by concerned party.
 - 5. Kindly give any details of training or orientation for RTI Act of the concerned officers or any staff member working in B & A Section only.
- 3. The CPIO/Chief Accounts Officer sent a reply dated 05.08.2022.

- 4. The Appellant has made the present appeal disputing on the details not provided by the PIO and refusal of access to information requested.
- 5. In view of the above the undersigned being the First Appellate Authority hereby decides as follows:
 - (i): CPIO/ Administrative Officer is directed to provide information of Sr.Nos (A) 1 & 2 within 10 days.
 - (ii) For Sr.Nos. (A) 3 & 4 and (B) 1 to 5, the PIO/ Chief Accounts Officer has already provided the desired information and the undersigned being the First Appellate Authority hereby upholds the decision of the PIO/ Chief Accounts Officer.

The appeal is therefore disposed of.
