1. This order shall dispose of the appeal filed by Shri Sanjay J. Chandekar in respect of ID No.68.
2. The appellant in his Original RTI application (online) dated 07.03.2022 had sought information about rules and regulations about Internal Committee at FTII including following points for which he made appeal :
  - (a) (Pt.No.5) Pl. provide the Appointment orders / Appointment letters given to the other IC members (like Ms. Lata Burande) that in the absence of the appointed Chairperson of IC (Ms. Suchitra Sathe), the particular member will work as an "In-charge, Chairperson(IC)".
  - (b) (Pt.No.6) Pl. provide all the Appointment Orders given to Ms. Suchitra Sathe for her selection as an External Faculty - Assistant Professor Video Editing for one Year Tenure from the date of an appointment i.e. from 05.01.2015 till the date.
  - (c) (Pt.No.7) Pl. provide All the "Short Term Appointment Orders" given to Ms. Suchitra Sathe for her selection as an External Faculty or a similar post or an Editor after completion of her 1 year Tenure (i.e. after the 1 year period was over which is under empanelment), against which the selection was done - (a) from 04.01.2016 till her further appointment for a year. (b) Short term appointments immediately after whenever her tenure of 1 year came to an end. (c) After 19.01.2022 & (d) from 20.01.2022 to 08.03.2022 or Earlier to this date. (e) Extension given to the earlier 1 year tenures.
  - (d) (Pt.No.10) Pl. provide all the Appointment Orders / Appointment letters given to Ms. Suchitra Sathe to hold the post of Chairperson (IC) or Presiding Officer (IC)

3. The PIO sent a reply through his letter dated 19.04.2022.
4. The Appellant has made the present appeal disputing on the reply given by the PIO as follows :

1. (Pt.No.5) Pl. give specific information w.r.t. the asked one & all those dates on which additional charge was assigned to the members by the chairperson of IC.

**No records available.**





**Mandate of the Committee :**

1. The Committee will function as per Sexual Harrasment of women at workplace (prevention, Prohibition and Redressal) Act, 2013 and Government of India orders issued in this respect from time to time.
2. The Committee will review the programmes and monitor implementation of development schemes for women in accordance with the guidelines suggested by the National Commission for Women.
3. Gender Sensitisation and Orientation.
4. Crisis Management and Mediation.
5. Enquiry and Redressal.

Any aggrieved person can approach any one of the above mentioned member(s) at any time.

Sexual Harrasment at workplace / academic institutions is a serious offence. This is punishable under the law. All concerned are required to take notice of legal procedures regarding the same.
