- 1. This order shall dispose of the appeal filed by Shri Sanjay Chandekar in respect of ID No.81.
- 2. The appellant in his Original RTI application dated 12.08.2022 had sought following information:
 - 1. Total Royalty / Licence Fees paid for the year 2019, 2020, 2021 & 2022. Please provide the receipts / acknowledgments or other evidences generated as the fees was paid thru' the "BharatKosh Portal".
 - 2. Total Salary given to Two Radio Programme Assistants each & One CTA in RadioFTII for the following period ${\mathord{\text{--}}}$
 - (1) June 2018 to July 2019
 - (2) August 2019 to March 2020
 - (3) April 2020 to March 2021
 - (4) April 2021 to March 2022
 - (5) April 2022 to August 2022
 - 3. Give total Income from Radio FTII to FTII from various projects taken / accepted from CRAUNICEF (like Bachpan Express I &II) in the following financial years each 2019-2020, 2020-2021, 2021-2022, April 2022 (SwasthyaSankalp) onwards till the date of RTI Reply.



- 4. Give total Funds given to RadioFTII / FTII from various projects taken / accepted from CRAUNICEF (like Bachpan Express I &II) in the following financial years each 2019-2020, 2020-2021, 2021-2022, April 2022 (SwasthyaSankalp) onwards till the date of RTI Reply.
- 5. Give total Income from RadioFTII to FTII from various projects taken / accepted from SMART, New Delhi in following financial years each 2019-2020, 2020-2021, 2021-2022, April 2022 onwards till the date of RTI Reply.
- 6. Give total Funds given to RadioFTII / FTII from various projects taken / accepted from SMART, New Delhi in the following financial years each 2019-2020, 2020-2021, 2021-2022, April 2022 (SwasthyaSankalp) onwards till the date of RTI Reply.
- 7. Give total Income from RadioFTII to FTII from various projects taken / accepted from SMART & Bill & Milinda Gates Foundation in following financial years each 2020-2021, 2021-2022.
- 8. Give total Funds given to RadioFTII / FTII from various projects taken / accepted from SMART & Bill & Milinda Gates Foundation New Delhi in the following financial years 2020-2021, 2021-2022.
- 9. Total expenditure over RadioFTII other than the Salary Component of contract employees in following financial years 2019-20, 2020-21, 2021-22, April 2022 till the date of reply.
- 10. Total expenditure over RadioFTII with the Salary Component of ALL employees working at present in RadioFTII in following financial years 2019-20, 2020-21, 2021-22, April 2022 till the date of reply.
- 11. Pl. furnish under which head of Non-plan expenditure, RadioFTII expenses are spent.
- 12. Pl. furnish the yearly budget of RadioFTII
- 3. The Appellant has made the present appeal disputing on the response from the PIO that the information received from the CPIO is incomplete, misleading and false.
- 4. It is seen that the Appellant had made the original RTI application on 09.08.2022 and the present appeal made on 11.09.2022. The first PIO (AO, FTII) forwarded the relevant portion of the RTI query to another PIO (i.e. CAO, FTII) while replying to the RTI Application 23.08.2022. The Second PIO has furnished the reply after receiving the query from first PIO on 25.09.2022. Since the PIOs have furnished the reply as per available records, and the Appellant made the appeal even before receipt of the reply from the second PIO, and the FAA upholds the decisions of the PIOs.



The appeal is therefore disposed of.
