- 1. This order shall dispose of the appeal filed by Shri K. Jagadeeswaran in respect of ID No.73.
- 2. The appellant in his Original RTI application dated 12.05.2022 had sought information/ documents/ inspection on FTII Sabbatical leave and other related information from 01.01.2005 to till date.
- 3. The PIO sent a reply through his letter dated 14.06.2022.
- 4. The Appellant has made the present appeal disputing on the reply given by the PIO that the information provided by the PIO is not satisfactory for the following reasons:

"The PIO had provided a copy of FTII sabbatical leave rules. Based on the same existing rules regarding grant of sabbaticals to teaching faculty, Shri Jagadeeswaran had applied for sabbatical leave in the past and same was denied by the FTII administration mentioning in the reply that FTII has proposed to modify the rules of sabbatical leave and is pending from Governing Council decision. However, the PIO has replied to his RTI dated 12.05.2022 that there is no such proposal available on records regarding proposal for change or modifications regarding Grant of sabbaticals to teaching faculty rules. Further the PIO has denied him permission to inspect the files related to his RTI matter, which is incorrect as per the rules of RTI Act 2005. Hence he kindly requested the First Appellate

Authority and Registrar Shri Sayyid Rabeehashmi, FTII, Pune to kindly look into this matter and provide him the photocopies of the related documents, list of applications received, permission granted or rejected and may kindly grant permission to verify all the requested said office records of FTII".

In view of the above, PIO is directed to provide a copy of the last proposal of modification of Sabbatical Rules, within 10 days, by mentioning the status of approval.

The appeal is therefore disposed of.

If you are not satisfied with the information provided, you may file an appeal before **Central Information Commission**, **August Kranti Bhawan**, **Bhikaji Cama Place**, **New Delhi – 110 066** within the stipulated time.
