- 1. This order shall dispose of the appeal filed by Shri Kishor Digambar Kure in respect of ID No.76.
- 2. The appellant in his Original RTI application dated 29.07.2022 had sought following information under the Right to Information act of 2005, (sub-section a (i), f, h, i, j, n, of section 2), (sub-section 1 (b) of section 4), (sub-section 1 (a), 3 (i) (ii) of section 6) (section 8, sub section 1 (j) of all information which cannot be denied to Parliament and the State Legislature.), (sub-sections 1,2 (a)(b)(c)(d)(e) of section 10) and (under sub-sections 1,2,3 of section 11:
 - 1. Test (Detailed information of the final marks obtained in the Joint Entrance JET) 2021 by each student qualified for Orientation and Interview of the admission process of 2021 in all departments of Film and Television wings with the official seal of the institute.
 - 2. The photocopy of the official attendance sheet of students, with names and roll numbers, present on each day of the orientation process as well as the interview of all departments of Film and Television wings with the official seal of the institute during the admission process of 2021.
 - 3. Photocopy of the official document of marks allotted to each student for each assignment by the examiners during the Orientation process with the name, designation and signature of all examiners present during the Orientation of admission process of 2021 in all departments of Film and Television wings with the official seal of the institute.
 - 4. Photocopy of the official document of marks allotted to each student by the jury for the interview during the interview process of admission of 2021 in all departments of Film and Television wings with the official seal of the institute.



- 5. Photocopy of the official document of remarks given to each student by the jury for the interview during the interview process of admission of 2021 in all departments of Film and Television wings with the official seal of the institute. Photocopy of the official document of break up of marks (JET, ORIENTATION, INTERVIEW) and final marks allotted to each student for the admission process of 2021 in all departments of Film and Television wings with the official seal of the institute.
- 6. All the above information should be given in a soft copy with written and stamp by email. The following information is subject to the Right to Information Act and it is illegal to deny it. FTII has declared the result of JET-2021 on 22 July 2022. The said information is related to the process before the announcement of the result and even when it is appropriate to give the information. But it has not been given. On the basis of which the results are declared. However, wrong and misleading reasons have been given by the CPIO.
- 3. The Dean (Films) sent a reply dated 25.08.2022
- 4. The Appellant has made the present appeal disputing on the reply given by the PIO that the information provided by the PIO is incomplete, misleading.
- 5. In view of the above, the undersigned being the First Appellate Authority hereby upholds the decision of the PIO for the reason that the admission process of 2021 Batch students is still in progress for finalisation. Thus, the details cannot be provided at this stage.

The appeal is therefore disposed of.

If you are not satisfied with the information provided, you may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066 within the stipulated time.
