 - (ii) Please provide details of the rule/rules governing secrecy of cut-off percentile for shortlisting of candidates for various courses (Why FTII does not announce cut off percentile at the time of short listing)
- 3. The CPIO, vide reply dated 27.06.2019 mentioned that "the information asked by you will be released only after completion of admission process for the year 2019. You are requested to keep the track of FTII website for the same.
- 4. As regard to point no. (i), it is to mention here that cut off is decided on the basis of the marks. Cut Off marks for each category (General, OBC[NCL], SC, ST etc) for short listing of candidates for admission to <u>Diploma in Film Direction & Screenplay Writing</u> for academic year 2019-20 are as follows:
