This order shall dispose of the appeal filed by Shri Aadhith V. Sathvin FATIP/A/2019/60008 in respect of ID No.34.

- The Appellant in his application dated 11.08.2019 and 13.08.2019 2. asked for the following information:
  - List of all Individual/organisations who are banned and whose · i) entry be restricted inside the campus of Film and Television institute of India, Pune and the reason/incident for which they are banned/entry restricted.
  - Documents of the committee report, list of names of the ii) committee members and the executive authority in the respective cases where an individual/organization is banned or whose entry is restricted inside the campus of Film and Television Institute of India, Pune

- 3. With regard to item no. (i) and (ii), the PIO {Dean(TV)}, vide reply dated 29.08.2019 informed that "Shri Sunil Polamuri was discontinued from the course on 16.7.2019 on the recommendations of the Course Director. The course ended on 26th July, 2019. Course name Writing for TV Fiction (24 weeks)
- 4. With regard to item no.(i) and (ii), the PIO {Administrative Officer/Dean (Films)}, vide reply dated 11.09.2019 informed that "The information sought is related to safety and security. Disclosure of such information may affect the security interest of Film and Television Institute of India, Pune and hence under Section 8(1)(g) of RTI Act, 2005 asked information cannot be provided.
- 5. The information given by the PIOs stands correct. Therefore, the appellant's contention that he has been provided incomplete, misleading or false information does not hold ground.

The appeal is therefore disposed of.

6. Ordered accordingly.

If you are not satisfied with the information provided, you may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066 within the stipulated time.
