- 1. This order shall dispose of the appeal filed by Shri Sapan in respect of ID No.111.
- 2. The Appellant has made the present appeal disputing that the CPIO/ Administrative Officer has not provided the details.
- 3. From the perusal of text of RTI First Appeal, it is noticed that at Point No.3 of the appeal, a different subject matter such as litigation, case number, court names, case status and details of lawyers involved in any judicial proceedings etc. has been mentioned, which was not in the original RTI Application. As such, the First Appellate Authority did not consider such issues as appeal and the matter which was in the Original RTI Application is considered as follows:
  - (a) On the point as in Sr.No.1 and 2 the Appellate Authority upholds the decision of the CPIO/Administrative Officer confirming that the requisite information cannot be provided under section 8 (1) (j) of the RTI Act, 2005.
  - (b) On the point as in Sr.No.3 & 5 of the original RTI application, the Appellate Authority upholds the decision of the CPIO/Administrative Officer confirming that the queries, suggestion, advices do not fall within the scope of definition of "information" under section 2 (f) of RTI Act, 2005.

- (c) On the point as in Sr. No.4 of the original RTI application, Appellate Authority upholds the decision of the CPIO/Administrative Officer confirming that the requisite information cannot be provided under section 8 (1) (j) of the RTI Act, 2005 and also the queries, suggestion, advices do not fall within the scope of definition of "information" under section 2 (f) of RTI Act, 2005.
- 4. The appeal is therefore disposed of.

If the Appellant is not satisfied with the information provided, he may file an appeal before **Central Information Commission**, **August Kranti Bhawan**, **Bhikaji Cama Place**, **New Delhi – 110 066** within the stipulated time.
