## ORDER

Date of RTI Application -23.08.2019Date of RTI Reply - 11.11.2019 - 18.11.2019 Date of RTI Appeal

This order shall dispose of the appeal filed by Shri R.M. Gavande in respect of I.D. No.39.

- 2. The appellant vide his RTI application dated 23.08.2019 had sought information originally from the Pay & Accounts Officer, Films Division, Ministry of Information and Broadcasting, Mumbai (enclosing pay fixation of Shri N.D. Mapari for confirmation) on the following :-
  - Whether the pay fixed as per Govt. Order No.35034/3/2008 Est (D) (i) dated 19.05.2009 [Para 6(2)] as mentioned in the pay fixation order is correct or not.
  - If the above pay fixation is correct whether the same order can be (ii) applicable to other staff i.e. Shri S.V. Kulkarni/R.M. Gavande, superintendent w.e.f. 11.10.2011
- The Pay & Accounts Officer, Films Division, Mumbai had forwarded the RTI application mentioning that the Service Books pertaining to the query are available with FTII.
- The PIO, FTII sent a reply to the Appellant informing that the asked information falls under query, which is not answerable under RTI Act, 2005.
- In his RTI appeal, the appellant contends that though the PIO has not given information mentioning that it falls under "query", the pay fixation may be made applicable to him. This request of the Appellant does not fall within the scope of RTI Act, 2005.

- Also, the Appellant has asked for additional "query" in the Appeal. 6.
- The appellant cannot raise fresh request for information at appeal stage. 7. However, the Appellant is permitted to inspect the necessary relevant records available in office of Administrative Officer, FTII to get clarified his doubts.
- In view of the foregoing, the appellant's contention that he has not been 8. provided information as per provisions of RTI Act, does not hold ground. The appeal is therefore disposed of.
- 9. Ordered accordingly.

If the Appellant is not satisfied with the information provided, he may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066 within the stipulated time.
