- 3. The Appellant has made the present appeal disputing the reply given by the CPIO that the details not provided and first appeal is due to misinterpretation, due to the typing mistake from FTII's side.
- 4. The undersigned has examined the First Appeal based on the application dated 28.02.2023 and noticed that there was a typographical error in Point No.5 of the RTI query wherein "reconstitution" was wrongly typed as "representation". The CPIO is being directed to make necessary arrangement for providing information with amendment within 10 days to the applicant.



The appeal is therefore disposed of.
