## ORDER

- 1. This order shall dispose of the appeal filed by Shri Ravish Pathan in respect of ID No.90.
- 2. The appellant in his Original RTI application dated 18.10.2022 had sought following information:
  - Total Marks Obtained by the Candidate RAVISH DILDAR PATHAN (i.e. Myself) with Roll No.17300479 including Marks Breakup for Written Test 20%, Orientation 50% and Interview 30%.
  - 2. Cut Off Total Marks required for selection to the course in General, OBC-NCL, SC, ST and EWS categories alongwith Marks Breakup for Written Test 20%, Orientation 50% and Interview 30%.
- 3. The Appellant has made the present appeal that Sr.No.2 information question, was answered by the concerned authority, is incomplete, misleading or false, on the following grounds-
  - 1. Why is this information required? The applicant is a student who wishes/might wish to reappear for the entrance test to this elite institute and therefore wishes to self-assess on the areas of improvement. The Marks Breakup between him and the last candidate will tell him about his weaknesses in the concerned areas (stages of exam) and therefore help him improve. Thus, without the response to Sr. No. 2, the sole response to Sr. No. 1 does not make sense due to absence of relativity and defeats the purpose.

- 2. There is no case of violation of personal rights of any candidate here since the marks of successful candidates in a public exam is a document of public domain (URL news snippets attached of various court/information commission rulings as a, b, c.)

- 4. In view of the above, given context of the appeal is not clear, FAA discussed this with the Appellant. Accordingly, as desired by the Appellant, PIO may provide details of cut off marks for Direction and Screenplay Writing course of FTII, within 10 days.

The appeal is therefore disposed of.
