ORDER

This order shall dispose off the appeal filed by Shri Shaikh Atikh Rashid in respect of I.D. No.03.

1. Present Shri Shaikh Atikh Rashid, Appellant on 24.03.2017
2. Present Shri S.K. Dekate, PIO/Administrative Officer
3. All present heard.
4. With regard to Item No.3, after hearing both the appellant and the PIO, two things emerge clearly. The sought information relates to appointment of members of FTII Society and Governing Council by Ministry of Information & Broadcasting. This is still under process at the Ministry. FTII is not authorised to disclose the relevant proposal, as it is under submission to the Ministry. In any case disclosing information at this stage is reasonably likely to prejudice the appointment process itself.

Secondly, the sought information also includes personal information which would cause unwarranted invasion of privacy of individuals at this stage. Therefore, this presents a case for invoking Section 8 (1)(j) of RTI Act.

With regard to items 4,5,6, the PIO has furnished "Matter in Process" which the appellant has contended is illogical. The PIO no doubt has erred in concluding that items 4,5,6 relates to item no.3. Nevertheless, the applicant had not asked for specific information. As brought out in the CIC judgement in case of S.K. Ranga Vs. Container Corporation of India Ltd. (Appeal No.CIC/OK/A/2006/00260, dated 2/1/2007), the applicant under the RTI Act should clearly specify the information sought in terms of Section 2[f] of the RTI Act. The applicant should therefore ask for specific information. The appeal is, therefore disposed off.

6. Ordered accordingly.

If you are not satisfied with the information provided, you may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066** within the stipulated time.
