In his RTI Application, with regard to some of the information sought, the appellant contends that he has been supplied with wrong information by the PIOs especially with respect to Terminal Benefits Committee recommendations. During the hearing, the appellant was asked to inspect the records to find out references to the Terminal Benefit Committee in Governing Council minutes. The PIO (Administrative matters) is directed to facilitate inspection of GC minutes from 1974 to 1980 within 10 days and provide attested copies of GC minutes desired by the appellant.

6. As regards, Item No.8 of the RTI Application, the PIO (Administrative matters) is directed to provide attested copy of Memorandum of Association.. As regards, Item no. 16 of the RTI application, PIO (Financial Matters) is directed to supply the requisite information within 2 days. The appeal is therefore disposed off.
8. Ordered accordingly.

If you are not satisfied with the information provided, you may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066** within the stipulated time.
