1. Class 10th and 12th Certificate and all Mark Sheets
2. Degree Certificate and all Mark Sheets
3. Caste certificate in case of SC / ST / OBC-NCL (Wherever applicable)
4. Certificate of Benchmark Disability (Wherever applicable)
5. Photo ID proof - Pan Card or Aadhar Card or Passport or Driving Licence or Voter ID Card
6. Admit Card of JET-2020

Candidature can be cancelled if any discrepancy is found between the self-attested scan copy of the above documents and the original copies of the same presented for scrutiny at the time of reporting for admission to FTII.

Candidates claiming OBC-NCL status may please note that the OBC certificate, including non – creamy layer status should have been issued on a date within **one year** before the closing date of receiving applications for JET-2020 i.e. 31.01.2020.
