

### 3<sup>rd</sup> Winter Film Appreciation Course FAQs

1. What is a Film Appreciation Course?

A: It is a course to learn how to see and analyse a film and what goes behind making of it.

2. Will there be hands on practicals in this course?

A: No. This is not film-making course but different components of film making will be taught through film clips and lectures.

3. Who is the Course Director?

A: Ms. Aruna Raje Patil, Alumna of FTII and multiple National Award winning Filmmaker. More details about her body of work is shared in the Concept note.

4. Is it a Certificate Course?

A: Yes. On successful completion of the course, participants would be given participation certificates subject to 90% attendance.

4. Film Appreciation through the lens of life means?

A. The Course is designed to integrate experiential insights of the human design with an understanding of how films are put together and are in fact, a created reflection of life from a particular point of view through characters, stories, subtext and overall visual and aural treatment.

5. What are the Course dates?

A: Course dates are 1-15 December 2019 (Sunday, 8th December 2019 will be a holiday)

6. What is the last date of submission of application?

A: The last date of submission of application is 11<sup>th</sup> November 2019.

7. Where shall I send/submit my application?

A: Ms. Anuradha Vajire, Librarian, Film and Television Institute of India, Law College Road, Pune – 411 004.

8. Is there a selection procedure?

A: Participants of the course will be selected on basis of their statement of purpose and also information provided by them in the application form.

9. How the participants will be communicated about their selection?

A: The names of the selected participants will be published on the FTII and NFAI website. The participants will also be communicated by email and phone call.

10. Where is the Course Venue?

A: Course will be conducted National Film Archives of India Phase 2, Near Doordarshan Kendra, Kothrud, Pune.

11. What is the Course Fee?

A: There is an administrative Fee of Rs. 800, while submitting the Application Form. Upon selection, participant shall pay an amount Rs. 18000 towards Course Fee.

12. What does Course Fee includes?

A: The Course Fee includes Course, Course Material, Working Lunch (Vegetarian) and Tea. The Course Fee includes 18% GST. It does not include cost towards Accommodation, Transport or Travel etc.

13. What is the mode of payment?

A: Both Administrative Fee and Course Fee shall be paid through SBI Payment portal only. Links to the SBI Payment portal are shared on both FTII and NFAI website.

14. Will the organisers provide stay to the participants?

A: Accommodation on sharing twin or triple basis will be facilitated. Details about the possible accommodation facilities will be suggested and contact details of the persons will be shared with the participants. Participants can contact and avail the accommodation for themselves.
