

## **CORRIGENDUM**

### **Amendment in FTII Prospectus 2021**

On 03<sup>rd</sup> Dec. 2021 FTII issued Prospectus 2021 on its website and also on JET 2021 admission portal (<https://applyjet2021.in>).

Following are amendments to the same;

#### **(1) Page no. 12:**

**At present:** Common Module – Semester – 1 is an Introductory Common Course for the students of Direction and Screenplay Writing, Cinematography, Editing, Sound Recording & Sound Design and Art Direction & Production Design. Acting students participate in this module for the few weeks. This module includes theory classes, practical sessions and collaborative & individual exercises for students to grasp basic concepts and skills related to film – making.

**To be read as:** Common Module – Semester – 1 is an Introductory Common Course for the students of Direction and Screenplay Writing, Cinematography, Editing, Sound Recording & Sound Design and Art Direction & Production Design. However, Screen Acting and Screenwriting students also participate in this module but only for limited duration. This module includes theory classes, practical sessions and collaborative & individual exercises for students to grasp basic concepts and skills related to film – making.

#### **(2) Page no. 41:'**

**At present:** Stage 2- Candidates in the JET – 2021 will appear for Orientation and Interview. (Details of category wise ratio of selection for Orientation and Interview is mentioned on page\*\*\*\*)

**To be read as:** Stage 2- Candidates in the JET – 2021 will appear for Orientation and Interview. (Details of category wise ratio of selection for Orientation and Interview is mentioned on page no. 65)

#### **(3) Page no. 55**

**At present:** Reservation Rules – SC/ST/PwD/Gen. EWS candidates and candidates belonging to OBC (Non – Creamy Layer) (as per Central list of OBC available on website – [www.ncbc.nic.in](http://www.ncbc.nic.in)) must upload a scanned copy of the original certificate, either in English/ Hindi, issued by a Competent Authority in the prescribed format as notified on the JET – 2021 website, while submitting the application on JET – 2021 portal. In case, the said certificates are in regional language, official translated certificates in Hindi/ English, notarized by a public notary, must be uploaded while submitting submitted alongwith the application and at the time of document

verification. Candidates failing to meet the above requirements will be considered as General candidate from the very first stage of Admission Process. i.e from the JET – 2021.

**To be read as:** Reservation Rules – SC/ST/PwD/Gen. EWS candidates and candidates belonging to OBC (Non – Creamy Layer) (as per Central list of OBC available on website – [www.ncbc.nic.in](http://www.ncbc.nic.in)) must upload a scanned copy of the original certificate, either in English/ Hindi, issued by a Competent Authority in the prescribed format as notified on the JET – 2021 website, while submitting the application on JET – 2021 portal. Candidates failing to meet the above requirements, will be considered as General candidate from the very first stage of Admission Process. i.e from the JET – 2021.

In case, the said certificates are in regional language, they have to be translated authorizedly into Hindi or English, notarized by a public notary and must be uploaded while submitting along-with the application and at the time of document verification. Failing to do so, the candidate may not get the benefit of claimed reservation.

**(3) Page 59 & 60:**

**At present:** (V) Candidates with benchmark disabilities may avail the services of writer/ scribe which must be indicated in the application form. Compensatory time of 20 minutes per hour will be given to those PwD candidates who are availing the services of a writer/ scribe.

(VI) The candidate with benchmark disabilities has an option of making an arrangement for the writer/ scribe on his/ her own. PwD candidates bringing their own scribe need to submit the prescribed affidavit at the time registration. Scribe must be undergraduate as far as his/ her qualifications are concerned and should not have any academic qualification in the film and/ or television.

**To be read as:** (V) PwD candidates with benchmark disabilities has an option of making an arrangement for writer/ scribe on his/ her own. The writer/ scribe must be an undergraduate and should not have any academic qualification and/ or professional experience in film, television or media. Such a candidate needs to submit a self declaration assuring that the services of writer/ scribe he/ she will be availing fulfill above stated requirements of under-graduation, academic qualifications & professional experience.

(VI) PwD candidates with benchmark disabilities availing the services of writer/ scribe will be given compensatory time of 20 minutes per hour.

All concerned are requested to kindly note the above stated amendments.
