ADVERTISEMENT FOR THE POST OF DIRECTOR, FILM & TELEVISION INSTITUTE OF INDIA, PUNE

Film and Television Institute of India (FTII), Pune, a premier Institute imparting training in various disciplines of Film and Television, is an autonomous organization under Ministry of Information & Broadcasting, Government of India registered under Societies' Registration Act, 1860. FTII, Pune invites applications from eligible Indian citizens for appointment to the post of DIRECTOR on deputation including short term contract or on contract as per standard terms of contract.

- 1. **DUTIES AND RESPONSIBILITIES**: Director, FTII is the Chief Executive of FTII and in-charge of both academic and administrative functions. He/She shall be responsible for proper administration of the Institute and for giving educational and training instructions. The Director functions as Member Secretary of the FTII Society and its Governing Council. He/She further exercises all such powers as delegated to him/her by the Governing Council.
- **PAY:** Pay Matrix Level 14 (PB-4 Rs. 37400-67000 + Grade Pay Rs.10000) of the Central Government and other allowances as admissible under Central Government Rules. The Director will also be eligible for a rent-free residential accommodation in the FTII campus.

3. ELIGIBILITY:

3. i. ON DEPUTATION (including short term contract)

Officers of Central Government/ State Governments/Autonomous Bodies/ Statutory Organizations/Semi-Government Organizations

(a) (i) holding analogous post on regular basis

OR

- (ii) with three years of regular service in the scale of Pay Matrix Level 13 (PB-4 Rs. 37400-67000 + Grade Pay Rs. 8700).
- (b) possessing the following educational qualifications and experience:

Essential

Graduate from a recognized University

Desirable

Experience of managing or making personal contribution in one of the following areas:

- * Writing Stories/Lyrics/Screen Play/Script for Films or TV programmes
- * Editing of Film/TV programmes
- * Production of Film/TV programmes
- * Direction of Film/Plays/TV programmes

3. ii. ON CONTRACT (as per the Standard Form of Contract)

Essential

- (a) Graduate from a recognized university.
- (b) Minimum 15 years' experience in the field of Film/Electronic Media, out of which minimum 3 years' experience in heading an Academic/Professional Institution/University/Department/Organization of national repute.

Desirable

- (a) Being a film maker of repute.
- (b) Having a post-graduate degree or diploma in cinema from a recognized University/Institute.
- (c) Having experience of teaching courses related to Films/TV in a recognized University/Institution.

4. AGE LIMIT AND TENURE

4. i. ON DEPUTATION

The upper age limit for appointment on deputation (including short term contract) shall not exceed 56 years. However, in case of candidates where age of superannuation in their parent department is 65 years or above, the upper age limit will be 62 years.

Period of deputation including the period of deputation (on short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed 5 years. Further, in case of candidates where age of superannuation is 65 years or above in their parent department, the period of deputation shall ordinarily not exceed 5 years or till incumbent attains age of superannuation, whichever is earlier.

4. ii. ON CONTRACT

Contract for a period of 3 years extendable up to 6 years or 60 years of age, whichever

is earlier.

Statutory Organizations and Semi-Government Organizations need to submit their

applications through proper channel. Applications not routed through proper channel

and sent after the prescribed time limit will not be considered.
