(I) HOW TO APPLY

- 1. Candidates need to apply through the Indian High Commission/Embassy as the case may be in their respective countries to ICCR, Government of India and then ICCR will forward their application to FTII Pune. Candidate may please look for ICCR A2A scholarship portal for ICCR application form.
- 2. Candidates are also required to fill up the application form of FTII (available on FTII website) and upload the same along with the scanned copy of educational certificates Secondary, Senior Secondary (10+2), Degree certificates etc. and other related documents (if any).
- 3. Candidates need to paste his/ her recent colour passport size photograph (not earlier than three months from the date of application) with clear front view of the candidate without cap and sunglasses.



4. Last date to receive FTII application is 23rd March 2024, 05:00 PM IST.

(II) GENERAL INSTRUCTIONS

- 1. Admission of candidate will be purely provisional and the decision of FTII in all matters relating to eligibility, acceptance or rejection of the applications and all other matters related to admission process will be final and binding on the candidates. No enquiry or correspondence will be entertained in this connection. Any dispute in regard to any matter referred to herein will be subject to the jurisdiction of Pune Courts alone
- 2. Candidates must submit credentials regarding their knowledge of English Language English as one of the subject at Senior Secondary level (10+2) or IELTS or TOEFL or equivalent certificate.
- 3. Medium of instruction at FTII is English.

- 5. Candidates with degrees / Certificates from foreign universities (University outside India) are required to submit the Equivalence certificate from Association of Indian Universities (AIU) with the application form.

1. Candidates should hold a valid passport.

2. Visa requirements: Candidate who is finally admitted to the institute must have passport clearly showing a student Visa for one year in view of the course duration of PG certificate course in Television.
